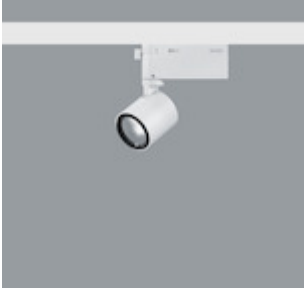
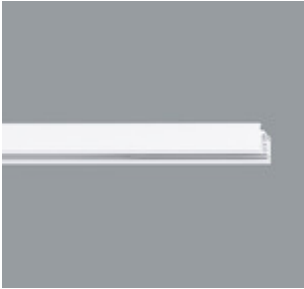
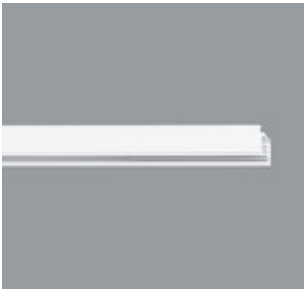

1. General

1.1 All goods shall be supplied exclusively on the basis of our general terms and conditions of sale and delivery as specified below and as amended from time to time. The customer shall be deemed to have accepted the terms and conditions of sale and delivery, at the latest, upon receipt of delivery or the first partial delivery. We do not need to refer to these terms and conditions in any following new commercial agreements. Thus, we are not obliged to include the terms and conditions of sale and delivery in each new order confirmation.

1.2 The customer's terms and conditions of purchase are not binding on us. Our terms and conditions of sale and delivery shall always take precedence. This shall also apply if we know, at the time of delivery to the customer, that the customer's conditions of purchase contradict or deviate from our terms and conditions of sale and delivery.

1.3 Supplementary agreements are only valid if they have been expressly confirmed by us in writing.

1.4 The parties' commercial agreement shall be deemed to have been made in Sweden and shall be interpreted and performed in accordance with Swedish law and shall be irrevocably submitted to the jurisdiction of the courts of Sweden.

1.5 If any provision of our terms and conditions is invalid or unenforceable, this shall not affect the validity of any other provisions. The customer is also obliged to accept that the invalid provision is replaced by another provision with the same economic and legal purpose.

2. Prices

All prices are ex works, and are calculated according to the price list in force at the time of order confirmation. For deliveries to be made later than four months after the order date, the price will be calculated according to the price list in force on the date of delivery. All prices are exclusive of taxes and levies such as VAT and environmental levies.

3. Payments

3.1 Payment shall be made no later than the due date without any deductions.

3.2 If the customer fails to pay on the due date, penalty interest will be charged at an interest rate which is eight percentage points higher than the reference rate set by the Swedish central bank (Sw. Riksbanken), as applicable from time to time.

3.3 The customer may only assert a right of retention if such right is based on the same contractual relationship.

3.4 Where deductions are made from our invoices, such deductions must be shown separately and supported by appropriate documentation attached.

4. Deliveries

4.1 Delivery dates have been estimated to the best of our judgement and are only binding if expressly and specifically confirmed by us. We are entitled to make partial deliveries.

4.2 If we are unable to fulfil our delivery and performance obligations due to circumstances which are beyond our

control and which we could not foresee or protect ourselves against with reasonable means, the delivery or performance may be postponed for as long as such circumstances continue. If delivery or other performance proves impossible, we shall be released from any obligation to deliver or perform.

4.3 We are not liable for any damage or direct or indirect loss due to a delay in delivery or non-delivery. The customer shall not have the right to cancel the contract unless expressly provided for by law.

4.4 All deliveries are made on behalf of and at the risk of the customer. Unless otherwise agreed, we shall select the method of delivery at our own discretion.

4.5 Orders over SEK 8.000, excluding VAT, are delivered free of charge within Sweden. For orders under SEK 8.000, excluding VAT, a delivery charge of SEK 300, excluding VAT, will be added.

4.6 The customer may not cancel orders or return goods without written agreement with us. In the event of an approved return, the goods must be unopened and in their original packaging. We charge a return deduction of at least 50% for handling cost.

4.7 Goods which deviate from the standard execution and any goods delivered more than 3 months ago cannot be returned or credited.

5. Execution

5.1 We reserve the right to make alterations and deviations in respect of shape, construction, and surface treatment, provided that this does not result in a significant deterioration in function or performance.

5.2 We do not warrant that our goods and services are suitable for the customer's intended use, unless otherwise agreed in writing.

6. Warranty

We warrant against errors and omissions as set out below:

6.1 If a delivery is found to be faulty, we will provide a replacement free of charge within a reasonable period of time, provided that the faulty delivery is returned to us.

6.2 If the replacement fails or is impossible, the customer may demand a price reduction or, if he so wishes, cancel the contract.

6.3 Each partial delivery shall be treated separately. Any faulty partial delivery shall not give rise to any claim in respect of the remaining partial deliveries.

6.4 Our liability under the warranty is limited to the amount paid by the customer for the goods. We will not compensate the customer or any third party for direct or indirect loss.

6.5 All warranty claims, including latent defects, shall expire no later than 24 months after the goods have left the factory in accordance with our delivery note.

6.6 The risk of loss or damage shall pass to the customer when the goods are collected or made available to the customer. If the goods are returned for reasons for which we are not responsible, the customer shall bear the risk until the goods are received by us.

6.7 We shall not be liable for damage in transit, unless the damage is covered by transport insurance taken out at the express request of the customer.

6.8 Our warranty does not cover goods which have been modified, rebuilt, added to etc. by a third party, i.e. goods which are no longer in the original condition in which they passed our final inspection and left the factory.

7. Export

Due to different specifications in different countries, it is the customer's

responsibility not to export our goods outside the EU without our written consent.

8. Governing law

The legal relationship between us and the customer shall be governed by the laws of Sweden.

9. Environmental levy

Due to the Swedish parliament's decision on producer responsibility for electrical waste, an environmental tax may be levied on electronic products.
